

4. Challenges





 Due to lack of infrastructure capacity (port facilities, railroads, vessels), the lead time and cost are not competitive.

Software



- Lack of harmonization of rules, lack of electronically shared data
- Lack of approach to manage as one consistent route

5. Efforts of Central Asian Countries to Overcome Challenges

Central Asia and Caucasus countries are working to overcome bottlenecks by

> Addressing Common Challenges

- Improved infrastructure capacity
- Reduction of costs and number of days required through digitization
- Harmonization of procedures in the region
- Single point of contact

6. Japan's Efforts

- ➤ Joint survey mission of the government of Japan and companies on Trans-Caspian Route (Oct. 2022)
- ➤ 12th Tokyo Dialogue of "Central Asia plus Japan" Dialogue on "Connectivity with Central Asia and the Caucasus" (Mar. 2023)
 - Experts and practitioners from Central Asian countries, Azerbaijan, and Georgia participated.
 - World Customs Organization (WCO) introduced initiatives in the region.

- JICA training program for government officials
- JICA and international organizations are collaborating on a project to facilitate customs clearance
